NOTE:

Age limit: Minimum 21 years and maximum 45 years, with relaxation as per rules. Relaxation in upper age limit shall be allowed to SC / ST / OBC / PwD candidates as per Government of India guidelines.

The position is purely temporary and co-terminus with the project. They should bring along with them filled-in application form in the attached proforma along with one set of self-attested copies of certificates related to qualification/age/experience etc. **All original certificates should be presented for verification.** No document other than pass certificate or provisional pass certificate will be accepted as proof of completion of a course. The date of interview

shall be the crucial date for determining age and educational qualification. No TA/DA will be paid for attending the interview. **Selection of candidates shall be provisional subject to verification of original certificates.** Relaxation in upper age limit shall be allowed to SC / ST / OBC / PH candidates as per Government of India guidelines. Impersonation is a cognizable offence & strictest disciplinary action shall be taken to punish the candidate/s caught guilty as considered suitable including but not limited to filing a FIR with the local police authorities.
