#### **GENERAL INSTRUCTIONS**

- 1. Age limit is 18-27 years as on <u>01.01.2011</u> relaxable for SC/ ST/ OBC etc. as per rules. There is no upper age limit for regular ICAR employees.
- 2. The last date for the receipt of application at NRC on Meat shall be within 30 days from the date of publication in the Employment News. Applications received after last date will not be considered.
- 3. Candidate applying for each of the above posts has to enclose a Bank Draft of Rs. 200/- (non ó refundable ) in favour of ICAR unit- NRC on Meat payable at Hyderabadó No Bank Draft is required for SC/ST candidates.
- 4. Application should be submitted strictly in the prescribed <u>typewritten</u> format, along with recent photograph, attested copies of testimonials, etc.
- 5. Candidates are required to necessarily enclose self attested copies in support of i) Date of Birth, ii) Essential Qualifications, iii) SC/ST/ OBC etc certificates, as prescribed by Govt. of India norms. along with their applications. Such applications which do not have required self attested copies of certificates, which are incomplete defective or with unsigned declaration will be rejected. No representation or correspondence regarding such rejection shall be entertained under any circumstances.

- 6. Those persons who are already in service may send their application according to rules (Through Proper Channel) and produce No objection Certificate (N.O.C.) at the time of interview.
- 7. The application should be submitted to the Assistant Administrative Officer, National Research Centre on Meat, P.B. No.19, Uppal Post, Chengicherla, Hyderabad- 500 039 (AP).
- 8. The envelope containing the application form should super-scribe as <u>o</u>Application for the post of Lower Division Clerk".
- 9. This institution will not be responsible for any postal delay.
- 10. Applications received after due date for any reason including postal delay will be rejected.
- 11. The prescribed essential qualifications are minimum and mere fulfilling higher qualification does not entail a candidate to be called for written test/ interview. Where the number of applications received in response to the advertisement is large and it will not be convenient or possible for the Institute to call all those candidates for written test/ practical test/interview, the Director, NRC on Meat, Hyderabad reserves the right to fix the criteria for calling/selecting the candidates on the basis of qualification, experiences etc. After screening the applications, the candidates will be called for written test/ practical test/ interview.
