Terms and Conditions:

- 1. The supporting/allied services staff/skilled/highly skilled staff/unskilled staff should follow strict attendance and alternative arrangements are to be made by the agency whenever anyone of staff/ supervisor is to go on leave under intimation to this office.
- 2. Changing of Staff/ Supervisor should be intimated to the Assistant Administrative Officer.
- 3. The Director, NRC on Meat reserves the right to reject any or all quotation in whole or in part without assigning any reason there for. The decision of the Director, NRC on Meat shall be final and binding on the Contractor /Agency in respect of clause covered under the contract.
- 4. The staff provided should also maintain secrecy and discipline in the premises of Council.

- 5. The highly skilled staff provided should be capable of reading and writing Hindi and English with minimum qualification of Graduate from any recognised University with knowledge of working on computer and one year experiences in similar field. Similarly, supporting/allied staff attached with officers/labs (excluding unskilled) should be capable of reading & writing Hindi & English with a minimum qualification of Middle Standard (excluding the cases of farm/Horticulture & landscaping/Cleaning-Sweeping work).
- 6. The contractor shall keep a complaint register with his supervisor, and it shall be open to verification by the authorized officer of NRC on Meat for the purpose. An complaints should be immediately attended to by the Agency.
- 7. The agreement is terminable with one month notice on either side.
- 8. The Contractor or his workers shall not sublet the work without prior written permission of the Director, NRC on Meat, Hyderabad.
- 9. The contractor or his workers shall not misuse the premises allotted to them for any purpose other than for which the contract is awarded.
- 10. Uniform with colour specifications of pattern approved by the competent authority of NRC on Meat, Hyderabad should be supplied by the contractor to the workers at his own cost and it would be ensured that the working staff are in proper uniform while on duty (for peons, cleaning/sweeping staff only)
- 11. The selected agency shall provided the necessary personnel for NRC on Meat, as per labour act prevalent in Hyderabad. The agency shall employ good and reliable persons with robust health of age group of 21 to 45 years, relaxable on exceptional cases. In case any of the personnel so provided is not found suitable by the NRC on Meat, the NRC on Meat shall have the right to ask for his replacement without giving any reason thereof and the agency shall on receipt of a written communication will have to replace such persons immediately (except in supervisory category where age can be relaxed).
- 12. The persons so provided by the agency under this contract will not be the employee of the Council and there will be no employee-employer relationship between the Council and the person so engaged by the contractor in the aforesaid services.
- 13. Payment for service contract will be made monthly upon submission of pre-receipt bill.
- 14. After physical inspection of the site, a very detailed assessment/ requirements of personnel for providing different services at the NRC on Meat shall have to be furnished alongwith the Tender. However, the Tender should indicate only the lump-sum amount in respect of all the services covered under this contract and that rates should not be proposed on the basis of manpower to be deployed under the contract. No request for alteration in the rates once quoted will be permitted within one year.
- 15. The rates to be quoted should include cost of each and every item including transportation cost, manpower cost and taxes etc. NRC on Meat shall not bear any extra charge on any account whatsoever ie. On EPF contribution, uniform, livery charges, OTA etc.,
- 16. The contractor will discharge all his legal obligation in respect of the Workers/Supervisors to be employed/deployed by him for the execution of the work in respect of their wags and service conditions and shall also comply with all the rules and regulations and provisions of law in force that may be applicable to them from time to time. The contractor shall indemnify and keep indemnified the NRC on Meat from any claims, loss or damages that may be caused to it on account of any failure to comply with the obligations under various laws. LIQUIDATED DAMAGES CLAUSE:

- 1. An amount equivalent to two days of contract amount, subject to a minimum of Rs. 1000/-(Rupees one thousand only) will be levied as liquidated damages per day.
