The upper age limit for Research Associate as on date of interview will be 40 years for men; 45 years for women.

Candidates possessing the essential qualification mentioned above only need to apply. No documents other than pass certificate or provisional pass certificate will be accepted as proof of completion of a course. The date of interview shall be the crucial date for determining age and educational qualification. HRA shall be paid at the rate determined by I.C.A.R. in case no Government accommodation is allotted to the Research Associate. No TA / DA will be paid for attending the interview.
