The date of interview shall be crucial date for determining age and educational qualification. HRA will be paid at the rate determined by ICAR in case no Government accommodation is allotted to SRF.

Non-production of any of original certificates for verification at the time of interview is liable to rejection of candidature. Any candidate who has deposited original certificates with the College/University/Employer should produce Custody Certificate.
