The cover containing quotation should invariably be super scribed. The quotations in person by hand will not be accepted.

 - c. For Air Conditioners
3. The quotation should remain open for acceptance for a period of 90 days from the date (due date)
4. An earnest money of **Rs. 15,000/- (Rupees Fifteen thousand only)** should be deposited in the form of Demand Draft / Banker's Cheque in favour of '**ICAR Unit - CRIDA**' payable at Hyderabad. The quotation will not be considered if earnest money is not deposited with the tenders.
