- Before quoting if required you may visit the institute during any working day between 09:30 AM to 04:30 PM except Second Saturday/ Sundays for assessing the actual conditions of the PA systems.
- The last date for submission of quotation is on or before 07-11-2016. Rates offered shall be F.O.R. CRIDA, Hyderabad Quotations should be sent by post only in a sealed cover addressed to the Director, Central Research Institute for Dry land Agriculture, Santoshnagar, Saidabad Post, Hyderabad – 500 059. The cover containing quotation should invariably be super scribed. The quotations in person by hand will not be accepted.

 - Repair / Servicing of PA systems (Audio Visual System) The quotation should remain open for acceptance for a period of 90 days from the date (due date)
- An amount of 10% of total order value as Security Deposit (Performance Guarantee) in the form of DD/ PO/Bank Guarantee/FDR is to be deposited by the successful Bidder only after receiving a communication from the Institute. In the event of any default of performance or conditions of supply, the security deposit will be forfeited.
