- While submitting quotation the original Gas supplier shall have certified producer of required gas grade.
- The firm should be authorized supplier to atleast two reputed analytical labs. A copy of proof may kindly be enclosed
- The last date for submission of quotation is on or before 28-09-2017
- Quotations should be submitted in a sealed cover addressed to the Director, Central Research Institute for Dry land Agriculture, Santoshnagar, Saidabad Post, Hyderabad - 500 059. The cover containing quotation should invariably be super scribed.
